## **ACP Hacked Documents**

Forensic computer specialists are limited to the last 45 days of computer activity on any given computer. David Cheley was illegally accessing the Near North system for eight months. Cheley used four different desktop computers and one laptop computer during that time. From Near North system records, it is proven that Cheley used his laptop for more than 80% of the time that he was illegally accessing the Near North system. However, Near North was not given access to Cheley's laptop and only given access to three of the four desktops that Cheley used. As a result, Near North was only able to forensically recover a very small percentage of the total number of illegally-obtained documents that were stolen from Near North.

From a severely limited sample, Near North can prove that 106 Attorney-Client Privilege (ACP) documents were stolen from Near North. Recognizing that from August 2001 until late April, 2002, Cheley was accessing the Near North system nearly every single day, and Near North only had access to 45 days of computer activity for 3 of the 5 computers, it is significant that Near North can prove that 106 ACP documents were stolen. Clearly, many more than 106 ttorney-Client Privilege documents were taken from Near North. See attached report of hacked Attorney-Client Privilege documents.
